Log in


Register as a user, whether a company or an individual, and provide your banking information. You will validate it on your cell phone with a 4-digit code. Registration with Elebbre will be validated within a few hours, according to our security and compliance policy.

Check out the items

Once registration is complete, you can log in to the website with your email and password, thus entering the Elebbre Marketplace. Here you will find the machines for direct sale; simply use the "Auction" filter to find specific items from the Online Auction.

Make the deposit

With registration completed and your chosen machine(s), a security deposit must be made so that you can effectively place a bid and participate in the auction. On the following slide, check the conditions.



Note

The security deposit will be valid for all the equipment that the client wants to participate in the auction, and it is not necessary to make a deposit per equipment (for example, if you want to participate in the bidding for 4 lots, simply add up the value of those lots and make a single deposit, following the conversion column).

Transfers outside of Chile must be made in US dollars. If the client is not the winner of the lot, the amount will be refunded within 5 business days. If the lot is won, the amount will be deducted from the final amount.

In this section, you can enter the next minimum offer indicated by the system. After placing your bid, you will receive one of these 3 messages:

"Reserve price not met": You must place higher bids to surpass the reserve price and be able to purchase this equipment. Note: The auction starting price is not the minimum selling price.

"You've been outbid, bid now!": You are not the highest bidder; you must place higher bids to surpass the bidder who currently has a higher offer than yours. Another bidder has surpassed your offer or placed a higher bid or Proxy bid (see Proxy bid explanation) that surpasses your last offer.

"You are the highest bidder, please wait!": You are the current highest bidder, and if no one surpasses you by the closing time, you will be the winner of this item.

You will receive a message to confirm each of your bids made and an email or notification when one of your bids is surpassed so that you can make a higher offer.

This section is used to make offers on equipment without needing to constantly monitor the evolution of bids. You can place an offer of the amount you consider paying for the item or a maximum offer.

The system will automatically make offers for you, increasing the minimum bid over the bids of other buyers, if any; otherwise, you will acquire the item for the value of the next minimum offer made by the last bidder.

You will only pay the maximum price of your proxy bid if other bidders make offers in the amount of your bid; otherwise, you will pay the amount at which the auction ends, below your proxy bid.

BID BOOST


Our state-of-the-art technological system includes a new feature in timed online sales, called Bid Boost, or "Offer Boost" function.

Bid Boost allows for reducing the remaining time of the sale of that lot to 24 hours. When a seller utilizes the Bid Boost function of Elebbre, they effectively shorten the remaining time for the sale to only 24 hours. Typically, auctions may have a longer duration, but this feature significantly speeds up the process.



If an item already meets or exceeds the Seller's Reserve Price, the seller themselves can activate the Bid Boost, and the closing of the sale for that lot will be reduced to just 24 hours, selling the asset to the highest bidder at the end of those 24 hours, without waiting for the originally agreed upon closing time and date.

Once selected, all bidders are immediately notified. After the seller activates the Bid Boost, the online auction platform sends immediate notifications to all bidders participating in the auction. These notifications inform them that the auction timeframe has been reduced to just 24 hours.








INVOICING

The purchased goods will be invoiced in the name of the legal entity or registered user of the buyer. Invoices will not be issued to third parties or altered for another buyer under any circumstances.



For sales made within Chile, Elebbre SPA will issue an invoice to the buyer, including the brokerage commission, which will be 10% of the equipment's sale value, plus the corresponding VAT. For equipment sold to countries outside of Chile, Elebbre will invoice the foreign buyer directly for the purchase value plus a 10% commission and VAT, until its exportation. Once the buyer sends the export documents, Elebbre will refund the withheld VAT.



ADJUDICATION OF ASSETS AND PAYMENT

Once an asset has been awarded, the successful bidder is obliged to pay the award price plus the brokerage commission, which shall be 10% of the sale value of the equipment, for equipment sold at 2,500 USD or more, and 250 USD of fixed commission for equipment sold at 2,500 USD or less, plus expenses and taxes, if applicable, within the terms and conditions indicated below.

All bids are final and firm, and no bidder may retract the offer during the sale process.

The buyer must make the corresponding payments within 5 working days after the award for local buyers, for foreign buyers the term will be 10 working days.










EQUIPMENT PICKUP AND DELIVERY

Only the awarded goods may be collected after full payment of the corresponding purchase invoices, brokerage commission, taxes, and contracted services in each case.



For registered or licensed equipment, it will be necessary to request the transfer or change of ownership for the equipment's withdrawal. The costs of these taxes or change of ownership procedures will be the responsibility of the buyer.





The pickup period will start from the next business day counted from the date of payment of 100% of the awarded value, commission, and applicable expenses. For buyers abroad who require shipping coordination for export, the pickup period may be extended upon request and agreement with Elebbre®.
